SUMMARY OF SCHEDULED MEETINGS

803rd meeting

Opening of the session and adoption of the agenda [1]

The session was opened at its 803rd meeting.

The Subcommittee decided to invite the representatives of Azerbaijan, Costa Rica, Dominican Republic, Tunisia and the United Arab Emirates to participate in the session as observers.

Space Law Symposium

A symposium on the theme of “National space legislation - crafting legal engines for the growth of space activities”, organized by International Institute of Space Law (IISL), was held during of the 804th meeting of the Legal Subcommittee. The symposium was co-chaired by Ms. Tanja Masson-Zwaan and Mr. Sergio Marchisio and presentations were made by Mr. Arnel Kerrest, Faculty of Law, University of Western Brittany, France, Mr. Henry Hertzfeld, Elliott School of International Affairs, George Washington University, United States of America, Mr. Steven Freeland, School of Law, University of Western Sydney, Australia, Mr. Philippe Montpert, Willis InSpace, France, Ms. Matxalen Sánchez Aranzamendi, European Space Policy Institute (ESPI), Austria, and Ms. Heike Wieland, European GNSS Supervisory Authority (GSA), EU.
